- Staff presented upon the upcoming Back to School event for which the Events & Programs Manager raised \$9,350 from sponsors including the Mavericks, Federales, Life in Deep Ellum and Uber.
- Staff presented upon the Bark Park renaming ceremony and survey, honoring the late Barry Annino. Staff encouraged board members to share the survey on possible improvements to be made to the park.

- The Public Safety Chairmen provided an update on crime stats. UUMV's have gone up and the committee is working to engage multifamily complexes to educate and plan to address these stolen vehicles as many are occurring outside the core area of activity closer to residences.
- Staff presented upon forthcoming changes to the See Say application utilized to intake requests for service and issues to the command center. The categories have been updated to reflect actual call types identified through a recent audit.
- The board discussed and suggested that with recent improvements in data collection, DEF should produce an annual report that can live on the website and detail out the metrics of success each year.

DEF Budget

- The DEF board approved staff to use the remaining funds allocated for janitorial services to complete the construction of the Deep Ellum Community Center at approximately \$10k.
- Kellan moved, Damany seconded, the motion carried.
- The Board further approved the creation, purchase and installation of a stand-alone historic designation sign to highlight Deep Ellum's recent inclusion on the national register of historic places. The Board approved up to \$8k. The motion carried.
